Resolution 2-2022 AUTHORIZING, PURSUANT TO TITLE 12, CHAPTER 44 OF THE SOUTH CAROLINA CODE OF LAWS 1976, AS AMENDED, THE EXECUTION AND DELIVERY OF THE FIRST AMENDMENT TO THE FEE IN LIEU OF TAX AND INCENTIVE AGREEMENT BY AND BETWEEN DAK AMERICAS, LLC AND CALHOUN COUNTY, SOUTH CAROLINA TO EXTEND THE INVESTMENT PERIOD THEREIN; AND OTHER MATTERS RELATED THERETO Councilman Nelson made a motion to pass Resolution 2-2022. Councilman Thornton seconded and the motion passed unanimously.

Resolution 3-2022 A RESOLUTION AUTHORIZING, UNDER CERTAIN CONDITIONS, THE EXECUTION AND DELIVERY BY CALHOUN COUNTY, SOUTH CAROLINA OF A FEE IN LIEU OF TAX AGREEMENT WITH A COMPANY CURRENTLY KNOWN TO THE COUNTY AS "PROJECT BEACH" WITH RESPECT TO AN INDUSTRIAL PROJECT IN THE COUNTY WHEREBY THE PROJECT WOULD BE SUBJECT TO PAYMENT OF CERTAIN FEES IN LIEU OF TAXES, AND WHEREBY "PROJECT BEACH" WILL BE PROVIDED CERTAIN CREDITS AGAINST FEE PAYMENTS IN REIMBURSEMENT OF INVESTMENT IN RELATED QUALIFIED INFRASTRUCTURE; AND PROVIDING FOR RELATED MATTERS. Vice-Chair Westbury made a motion to pass Resolution 3-2022. Councilman Thornton seconded and the motion passed unanimously.

### **Second Reading**

AN ORDINANCE TO PROVIDE AND ADOPT CALHOUN COUNTY COUNCIL ELECTORAL DISTRICTS BASED UPON THE 2020 CENSUS was presented for **Second Reading**. Councilman Nelson made a motion to pass Second Reading of Ordinance 2022-1. Vice-Chair Westbury seconded and the motion passed unanimously.

### 2. **ORDINANCE 2022-2**

### **Second Reading**

AN ORDINANCE AUTHORIZING THE DEVELOPMENT OF A JOINTLY OWNED AND OPERATED INDUSTRIAL/BUSINESS PARK IN CONJUNCTION WITH ORANGEBURG COUNTY, SUCH INDUSTRIAL/BUSINESS PARK TO BE GEOGRAPHICALLY LOCATED IN CALHOUN AND ORANGEBURG COUNTIES AND ESTABLISHED PURSUANT TO SECTION 4-1-170 OF THE CODE OF LAWS OF SOUTH CAROLINA, 1976, AS AMENDED; TO PROVIDE FOR A WRITTEN AGREEMENT WITH ORANGEBURG COUNTY TO PROVIDE FOR THE EXPENSES OF THE PARK, THE PERCENTAGE OF REVENUE APPLICATION, AND THE DISTRIBUTION OF FEES IN LIEU OF AD VALOREM TAXATION; AND OTHER MATTERS RELATED THERETO was presented for **Second Reading.** Vice-Chairman Westbury made a motion to pass Second Reading of Ordinance 2021-1. Councilman Thornton seconded and the motion passed unanimously.

### **3. ORDINANCE 2022-3**

### First Reading

#### BY TITLE ONLY

AUTHORIZING THE EXECUTION AND DELIVERY OF A FEE-IN-LIEU OF TAX AGREEMENT BY AND BETWEEN A COMPANY CURRENTLY KNOWN AS "PROJECT BEACH" (THE "COMPANY") AND CALHOUN COUNTY, WHEREBY CALHOUN COUNTY WILL ENTER INTO A FEE-IN-LIEU OF TAX AGREEMENT WITH THE COMPANY AND PROVIDING FOR PAYMENT BY THE COMPANY OF CERTAIN FEES-IN-LIEU OF AD VALOREM TAXES; PROVIDING FOR SPECIAL SOURCE REVENUE CREDITS IN CONNECTION WITH SUCH AGREEMENT; PROVIDING FOR THE ALLOCATION OF FEES-IN-LIEU OF TAXES PAYABLE UNDER THE AGREEMENT FOR THE ESTABLISHMENT OF A MULTI-COUNTY INDUSTRIAL/BUSINESS PARK; AND OTHER MATTERS RELATING THERETO was presented for First Reading by Title Only. Councilman Nelson made a motion to pass First Reading by Title Only of Ordinance 2022-3. Vice-Chair Westbury seconded and the motion passed unanimously.
