Mrs. DeBorah Jamison of the Food Policy Council gave a presentation to Council regarding new initiatives in the Tri-County area and the Community Health Improvement Plan (C.H.I.P.). She gave a hand out and told of future involvements with counties to help navigate the policies around food and healthy distributions.

Mr. George Gates appeared before Council to speak about the Emergency Abatement Ordinance. Mr. Gates told of reasons he believed the ordinance should not be enforced on his property and asked Council to reconsider. He asked Matt Trentham of the Calhoun County Sheriff's Department to come forward to give clarification. Prior to, the Judge's ruling was to uphold the ordinance.

Mr. John Deloache, attorney with the SC Association of Counties came to clarify any issues surrounding the Form of Government change. With the current form, Council holds both legislative and administrative duties. The change would allow the Administrator to make decisions as long as he is in line with statutes and ordinances. It was highlighted that Council is not making the decision to change, just to ask the public via referendum.
