- 8. Angie Culler Matthews spoke in support of PC denial, residents understanding of growth being managed and opposition to Form of Government ordinance.
- 9. Josh Rabon gave remarks in support of the development and cited no development in the flood plain, current zoning of the property and traffic increasing regardless of the subdivision.
- 10. Channing Mack spoke in opposition of the development and growth to be kept under a threshold.

After questions and discussion, the Hearing was closed.

Third Reading of Ordinance 2022-16. Vice-Chairman Westbury made a motion to pass Third Reading of Ordinance 2022-16. Councilman Thornton seconded. Chairman Haigler, Vice-Chairman Westbury, Councilman Carson and Councilman Thornton voted in favor and Councilman Nelson opposed. The motion passed with 4-1 vote

Chairman Haigler opened a Public Hearing on <u>ORDINANCE 2022-17</u> AN ORDINANCE FOR ADOPTION OF AMENDMENTS TO THE CALHOUN COUNTY ZONING ORDINANCE. There were no comments or questions; therefore, the Hearing was closed.
