Call to Order

Chairman Haigler called the meeting to order.

Invocation

Invocation was offered by Councilman John Nelson.

Approval of Agenda

Vice-Chairman Westbury made a motion to amend the agenda to add First Reading by Title Only of Ordinance 2022-22 AN ORDINANCE TO AUTHORIZE AND APPROVE THE EXECUTION AND DELIVERY OF A FIRST AMENDMENT TO THE FEE IN LIEU OF TAX AGREEMENT BETWEEN LONE STAR SOLAR, LLC AND CALHOUN COUNTY, SOUTH CAROLINA, DATED AS OF MAY 10, 2021, AND OTHER MATTERS RELATED THERETO. The motion was seconded by Councilman Nelson, and passed unanimously.

Vice-Chairman Westbury made a motion to amend the agenda to table Resolution 16-2022 A RESOLUTION SETTING THE MILLAGE AND APPROVING THE LOCAL OPTION SALES TAX CREDIT FACTOR FOR THE 2022-2023 FISCAL YEAR until the appropriate documentation becomes available. The motion was seconded by Councilman Thornton, and passed unanimously.

Vice-Chairman Westbury then made the motion to approve the amended October 10, 2022 meeting agenda, and was seconded by Councilman Nelson. The motion passed unanimously.

Public Comments on other matters

Tris Waystack spoke on the live burn training facility with concerns as to why it was torn down and rebuilding with taxpayer dollars.

Approval of Minutes

Minutes of the September 26, 2022 regular meeting were presented for approval. Motion was made by Vice-Chairman Westbury and seconded by Councilman Carson to approve the minutes as presented. The motion passed unanimously.

Committee Reports

Councilman Thornton reported on the meeting held with the Public Services Committee, in which it was decided to move forward with the fire training facility in the location discussed.

Appointments

Appointments were made to the Regional Aging Advisory Committee. Ruth Bonnette and Doris Harley were appointed. The motion was made by Chairman Haigler, seconded by Councilman Thornton; and passed unanimously.

Kenneth B. Vinson of Heyward Community Development Alliance and the Heyward Community Park was unable to attend.

Resolutions

Agenda was amended to delete item.

New Business

The meeting cancellation was taken off the table when the Agenda was amended.

Council approved the Sandy Run Volunteer Fire Department Water Pumper Tanker bid to Spartan Fire in the amount of \$518,747. Vice-Chairman Westbury made the motion, and was seconded by Councilman Nelson. The motion passed unanimously.
