Approval of Agenda

Public Hearings

Chairman Haigler opened a Public Hearing on **Ordinance 2024-12** AN ORDINANCE AMENDING CHAPTER 26 OF THE CALHOUN COUNTY CODE OF ORDINANCES REGARDING THE UNLAWFULNESS OF EXCESSIVE NOISE AND NUISANCES.
