#### Call to Order

### Approval of Agenda

## **Reconsideration of Final Reading**

Ordinance 2025-5 AN ORDINANCE AMENDING CHAPTER 30 OF THE CODE OF ORDINANCES OF CALHOUN COUNTY REGARDING FIRE PREVENTION AND PROTECTION TO RECONSTITUTE THE CALHOUN COUNTY RURAL FIRE DISTRICT; ELIMINATING ALL EXISTING FIRE PROTECTION AREAS; APPROPRIATING FUNDS TO AFFECT THE REDEMPTION OF ANY OUTSTANDING BONDS AND OTHER OBLIGATIONS; REQUESTING AND ACCEPTING DEDICATION OF COUNTY FUNDED FIRE CAPITAL EQUIPMENT AND FACILITIES; AND OTHER MATTERS RELATING THERETO was presented for reconsideration to make July 1, 2025 the effective date. All were in favor of reconsideration. Councilwoman Bonnette made comments regarding the ordinance. Deputy Administrator Hall spoke on the ordinance and told that it is the date needing to be amended.

### **Action of Reconsideration**
