

# DELINQUENT TAX SALE

To prevent properties listed below from being sold, payments will be accepted through November 1, 2024 at the Delinquent Tax Office from 9:00 A.M. until 5:00 P.M. Payments postmarked November 1, 2024 will be accepted. The Delinquent Tax Office will be closed November 4, 2024 and WILL NOT accept 2023 property tax payments. Bidders must be pre-registered with the Tax Collector's Office prior to the sale; there will be no registering the day of the sale. Registration will be available from 9:00A.M. - 5:00P.M. daily October 1, 2024 through November 1, 2024 at the Tax Collector's Office. Bidders may also register by mail by downloading the bidder registration form, as well as the tax sale rules & regulations, on our website at [www.calhouncounty.sc.gov](http://www.calhouncounty.sc.gov). Due to COVID-19, only registered bidders will be allowed in the auction area. Everyone attending is asked to observe COVID-19 guidelines. **The methods of payment are Cash, Cashier's Check and Money Orders. All payments must be rendered at the end of the sale.** No sale payments will be accepted the following day. All bids are final. Failure to comply could result in a \$500 fine. **In accordance to South Carolina Code of Laws Section 12-51-40, Real Estate properties to be sold will be advertised three weeks prior to sale.** Mobile Homes will be advertised the last two weeks before the sale. The purchaser of property at a tax sale acquires the title without warranty and buys at his/her own risk. The County is not liable for the Quality or Quantity of the property sold.
