- 1. An amended **Resolution 19-2021** SETTING THE MILLAGE AND LOCAL OPTION SALES TAX CREDIT FACTOR FOR 2021-2022 was presented for passage. Administrator McLauchlin advised that the only change to the Resolution that was passed on September 27 and amended on October 10 was a correction to a clerical error on the Local Option Sales Tax Credit Factor.
